*How will the items you are requesting for purchase help prepare your students to be college and career ready in the 21st century?

The RealityWorks items will help prepare our students to be college and career-ready by providing them with technical skills needed in the agriculture industry. As students graduate from the Clarinda Agriculture Program, not only will they be competent with content knowledge and terminology, but they will have the basic technical skills and techniques to correctly perform different procedures for each of the various items. Students will be able to use the concepts learned from the simulators with other livestock species and plant production systems. The simulators will allow our students to gain technical skills which will give them a unique advantage over other students who have not had the same opportunity when applying for college and career opportunities post high school.

The simulators and hydroponics system will be meeting RPP goal # 1 "Promote career and college readiness through thoughtful career guidance and purposeful academic and technical planning practices" and RPP goal #2 "Promote high-quality, integrated career and technical education programming". The simulators and hydroponics system will provide students the opportunity to gain hands-on, work-based learning experiences without any of the "expense" beyond the original purchase. Students will not have to travel or spend time outside school hours to obtain skills that will be useful to them post high school. These concepts could easily be taught through discussion,

worksheets, pictures, and videos in the classroom but the utilization of a simulator goes one step further to provide students with high-quality, real-world, hands-on experiences.

*How will the items you are requesting support the continued development and implementation of your district(s)' Programs of Study?

The Clarinda agriculture program of study is focused on providing students with high-quality technical education to prepare them for careers after high school. The purchase of these RealityWorks simulators will ensure both our plant systems and animal systems pathways have the materials necessary to provide our students with these experiences. All students in our program are required to take 7th and 8th-grade exploratory ag courses. These simulators will be used in the exploratory course as well as our more advanced courses to ensure that 100% of students have access to utilize these materials. The younger grades will utilize the simulators to study basic agriculture topics and terminology, while the more advanced grades will utilize them for their technical skills attainment.

*How will funds received from this Grant be used to support all students including <u>special</u> <u>populations</u>?

The purchase of the RealityWorks simulators will provide 100% of students enrolled in the Clarinda Agriculture Program the opportunity to gain hands-on experience. For our non-traditional agriculture students, it may provide them with their first experience of hydroponics, injections, meat cuts, and suturing which could potentially lead to college and career opportunities if they further desire. The simulator would also provide our special needs or physically handicapped students the opportunity to participate in a safe, controlled environment while obtaining the same skills and experiences as other students in the class. Depending on the needs of the individual students, the simulators can be placed on a table, stand, or on the floor for any student to have appropriate and easy access. Our traditional agriculture students may have an understanding of these topics or even limited experience. The simulators will provide these students the opportunity to demonstrate, improve, and refine their technical skills. This will also provide a great opportunity for our traditional agriculture students to share their knowledge and experience with the non-traditional students enrolled in our program.

*Provide a rationale explaining why your district/department is in need of this funding beyond what you have identified in the above responses?

The Clarinda Agriculture Department is well supported by our school administration and the Clarinda community. While we are grateful to have such great support, unfortunately, the financial funding is not endless. Our program and students will greatly benefit from the financial funding to purchase the RealityWorks simulators in the ways mentioned in the above answers. If the Clarinda district were to purchase one simulator, it would leave little to no funding in the agriculture budget for other materials and supplies to be purchased for the school year. It simply is not feasible, nor fiscally responsible, for our district to use the majority of the agriculture budget on a few items.
