RESOLUTION FOR A CONVEYANCE OF REAL PROPERTY

WHEREAS, pursuant to notice published as required by law, the Board of Directors of the Clarinda Community School District on the 12th day of August, 2026 held a hearing on the proposal to convey an interest in real property and the extent of objections received from residents or property owners as to said proposed transaction has been fully considered; and, accordingly the following action is now considered to be in the best interests of the District and residents thereof:

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE CLARINDA COMMUNITY SCHOOL DISTRICT:

Section 1. That the real property described herein shall be conveyed by the District to City of Clarinda for good and valuable consideration. Conveyance by the District shall be by Gift Agreement.

Section 2. The Board President and Secretary are authorized to sign all conveyance documents for the real property described herein.

Section 3. The Board President, Secretary, Superintendent, and administrative officers of the District are authorized to take all actions necessary to complete the above-described transaction, including execution of ancillary documents.

Section 4. The real property is locally known as Page County Parcel No. 083118012500, and is legally described as follows: Blocks 28 and 41 AND Vacated Stuart Street lying between Blocks 28 and 41 AND West 20 feet of vacated 12th Street adjoining Block 41 on the East thereof AND East 12 feet of vacated 13th Street adjoining Block 41 on the West thereof, All in Original Plat of City of CLARINDA, Page County, Iowa
